# DETAILS OF THE FORMULA

The regular employee share ownership offers testify to the desire to associate Crédit Agricole group employees closely with the Group's potential performance by offering them long-term benefit from the value created and gradually strengthening the employee shareholding in Crédit Agricole S.A.'s capital. With the Classique plan, you can invest in Crédit Agricole SA shares on preferential terms.

## A simple formula

to benefit from a discount on subscription and, over time, from dividends and from the potential performance of Crédit Agricole SA shares.

## When you subscribe

- You benefit from a **20% discount** on the reference price of the Crédit Agricole SA share. This investment involves a risk of loss of capital. Therefore, you assume the typical risks associated with investing in shares. Your capital is not guaranteed and there is a possibility of you not getting it back in full when you sell your shares.

## During the lock-in period until 31 May 2030

- The value of your investment reflects the changes in value of the Crédit Agricole SA share price, **whether it goes up or down.**
- You receive any **dividends** paid by Crédit Agricole S.A. and they are paid to you directly.
- You benefit from the advantages inherent in the Crédit Agricole S.A. International Savings Plan (PEEGI): account administration fees are paid by Crédit Agricole S.A.

During your placement, the value of your investment will also vary according to fluctuations in the exchange rate between the euro and your currency. If the euro appreciates against your currency, the value of the shares in your currency will increase. However, if the euro depreciates against your currency, the value of the shares in your currency will decrease.



### REFERENCE PRICE

the average of the Crédit Agricole SA share opening price on the Euronext Paris stock exchange over the 20 trading days preceding the decision that determines the opening of the subscription period (decision scheduled for 23 June 2025).

### SUBSCRIPTION PRICE

reference price minus a 20% discount. This is the price at which you will be able to subscribe to shares in Crédit Agricole SA.

# IN PRACTICE

What you need to know to subscribe!

## Who can participate?

To participate in the offer, you must:

- **have an employment contract** in force with a Crédit Agricole Group company participating in the offer for at least one day during the subscription period (between 24 June and 8 July 2025, inclusive<sup>1</sup>),
- and have **been employed in the group for at least 3 consecutive months** or not between 1 January 2024 and the closing date of the subscription period.

## How much can I invest in the ACR 2025?

- Your subscription must be for a minimum of one share and a maximum number of shares corresponding to €40,000<sup>2</sup>.

**Summary:** You must also make sure that your investment does not exceed 25% of your estimated gross annual salary for 2025.

## How to pay and when?

- You pay in local currency as instructed by your Human Resources Department; the exchange rate applied is that of the working day before the subscription price is set.
- Please note that your subscription in your local currency will be converted to euros at that rate, and then invested in Crédit Agricole SA shares listed in euros on the Paris stock exchange.



## When and how can I participate?

**From 24 June (12:00 (Paris time)) to 8 July (20:00 (Paris time)) 2025, inclusive:**

1. **Log on** to [www.acr.credit-agricole.com](http://www.acr.credit-agricole.com) for more information about the offer and the terms and conditions.
2. **Click** on “Subscribe”.
3. **Log in** with the username and password you will have received by post or email.
4. **Enter** the number of shares you want to subscribe on the subscription screen.
5. **Confirm:** a confirmation email will be sent automatically.
6. **You can change** your subscription on-line until 20:00 (Paris time) on 8 July 2025<sup>1</sup>. After this date, your subscription order will be **irrevocable**.

## What happens in the event of over-subscription?

32 million shares will be issued as part of the offer. If demand exceeds the total number of shares, the largest subscriptions will be capped at a limit designed to ensure that the total number of shares offered is reached, but not exceeded.

- If your application is lower than or equal to this limit, it will be **honoured in full**.
- If it is higher, it will be **honoured up to the limit**.

## When does the lock-in period end?

If your circumstances are considered eligible for early redemption, you should contact your Human Resources Department.



### STARTING

**Your investment will be available from 1 June 2030.**

- You will also be able to sell all or some of your shares.

The opening price of the Crédit Agricole SA share is recorded every day.

## 23 JUNE

The subscription price is announced on the offer website and displayed at your workplace.

## 24 JUNE

The subscription site opens at 12:00 (Paris time); you can then enter your subscription.

## 8 JULY

The subscription period ends at 20:00 (Paris time).

## STARTING FROM 21 JULY

You pay your subscription as instructed by your HRD.

## 28 AUGUST

The shares are issued by Crédit Agricole S.A. and delivered to the subscribers' accounts.
